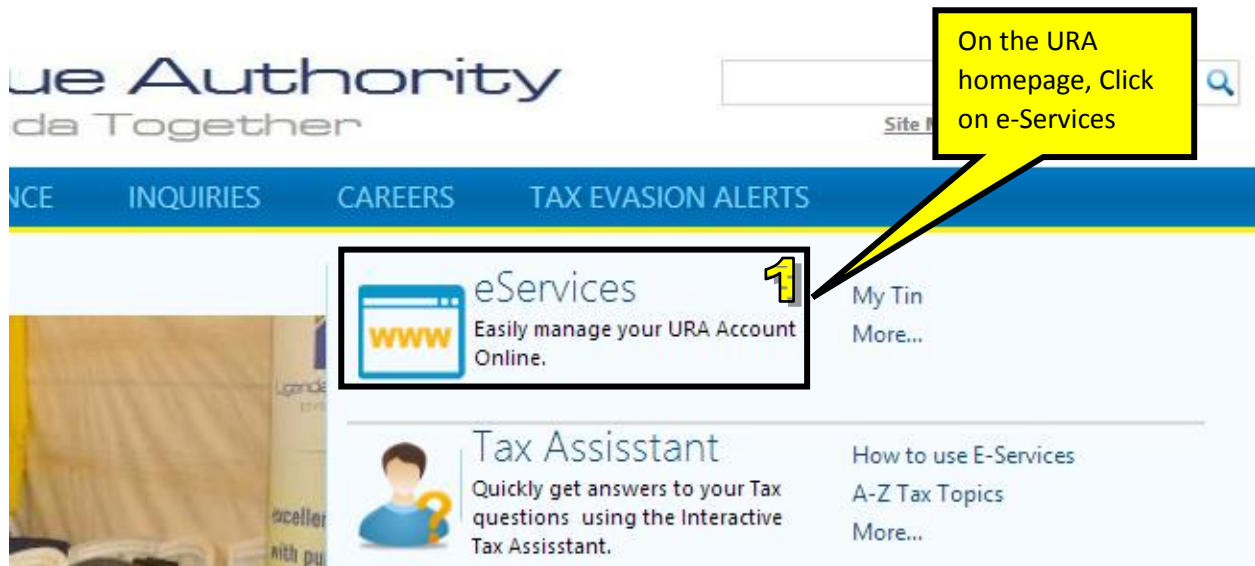
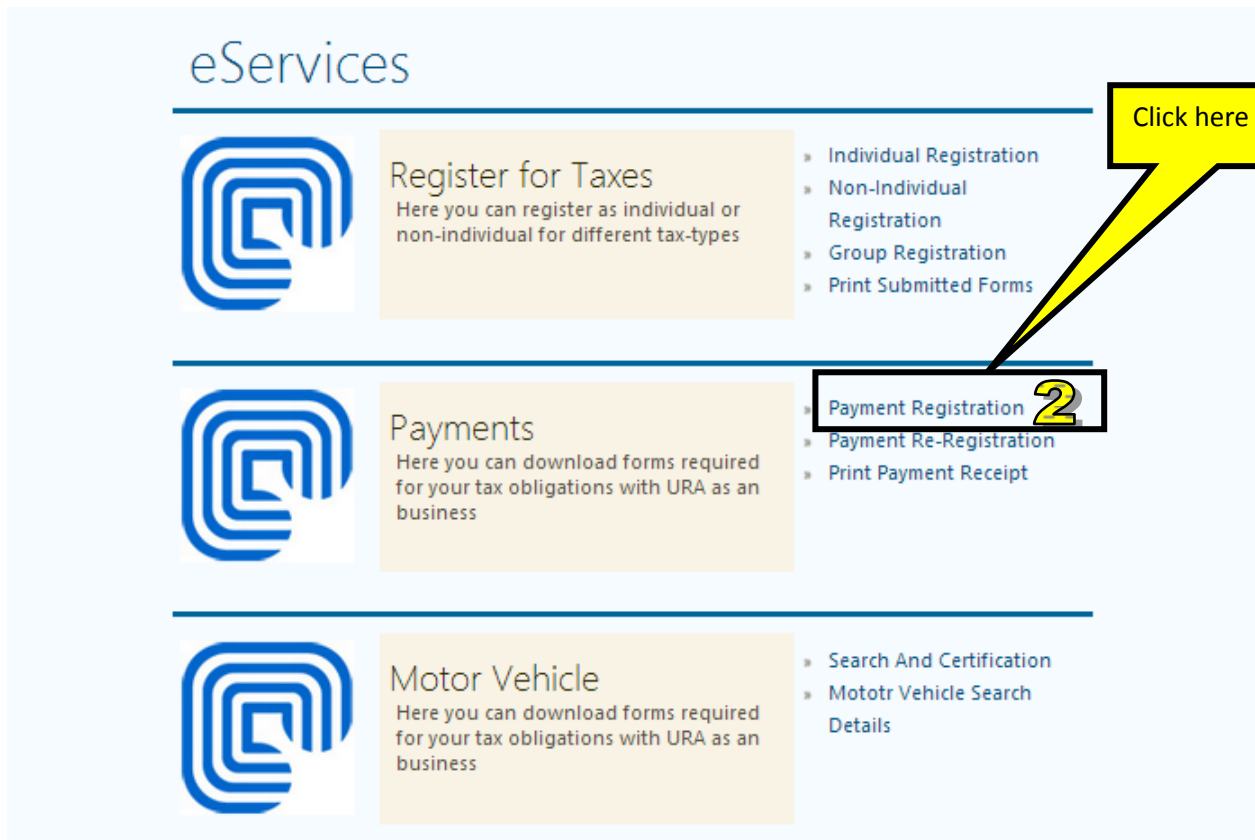


How to register a payment on the web portal
